The information we hold is

- Phone numbers (supplied by you, to contact you regarding orders and queries)
- Email Addresses (supplied by you, to contact you regarding orders and queries and marketing)
- VAT number (supplied by you, for trading purposes)
- Bank details (supplied by you, for accounts payments)

Polydeck holds your information for the following purposes

- To administer and manage our relationship with you
- To process and create new jobs on different sites
- To deal with any queries we receive from you
- For the purpose of any corrective action
- To provide you with information of any changes to our business
- For the purpose of debt recovery in case of a non-payment

Polydeck takes the security of your data seriously. We use appropriate technical and organisational measures to ensure that we meet the requirements of the National and European Union Laws. No unauthorized personnel have access to your information. The information you supply us is only shared within our business to enable efficient trading with your company. Your information is never sold or passed on to a third party.

Polydeck Resin hold information within our SAGE accounts package with multi layered password security and within our Microsoft office 365 account also password protected. Invoices are locked away in archive and kept on site for 7 years
